- **Call opened from 1 April 2013 until 30 June 2013**
- **New round 1 July**
- **Maximaal duration of a project 24 months**
- **Project start 1 september 2013**

deskresearch
focusgroup
development action plan
max 3 months
- **Phase 2:**
Transnational comparison
Reflection group, peer reviews and study visits
development and validation
max 15 months
- **Phase 3:**
Experimentation, implementation en dissemination
max 6 months

Transnationale partnerschap is compulsory.

3 kind of projects

1. **Joint Development projects**: the Flemish promotor will develop together with a transnational (and national) partners product, instrument, method, system, etc. The project has to be implementational in Flanders,
2. **Import projects**: research and comparison of relevant products, instruments, methods, etc of another member state. The most relevant product will be selected and adjusted to the Flemish context with final goal the implementation of the product in Flanders
3. **Export projects**

- **TOTAL 2.500.000 EUR**
- **ESF 1,00.000 EUR**
- **VCF 1.500.000 EUR**
- **Maximum subsidy per project 250.000 EUR**
(100.000 EUR ESF and 150.000 EUR VCF)

- **TOTAL 1.500.000 EUR**
- **ESF 900.000 EUR**
- **VCF 600.000 EUR**
- **Maximum subsidy per project 250.000 EUR**
(150.000 EUR ESF and 100.000 EUR VCF)

Specic limitation of the generic financial criteria:

1. *Heading internal staff costs : standardschale*
 - A111 (0-5 jaar) 64,077,41 €
 - A111 (6-10j) 71,751,75€
 - A111 (11-15 j) 78,131,46€
 - B111 (0-5j) 47,247,25€
2. External staff–
125€/h
3. Heading 3 (direct costs) and 5 (transnational costs)- Real costs
4. Indirect costs 15% of headings 1,3 en 5 uit het kostenschema (forfait)
5. Foreign staff – non eligible for finance
6. Costs transnational partner(s)- Reciprocity
(hotel + transpotation costs)

- 3 months after phase 2
- 3 months after end of project

- **Criteria:**
 - Usefulness
 - Accessibility
 - Innovation
 - Empowerment
 - Sustainable development
 - Relevancy
- **A positive validation necessary to start with phase 3**

- **Is there already an existing offer? If yes, describe this current Flemish or Foreign offer , beschrijf het huidige aanbod hier en/of in het buitenland. If yes, why is this offer inadequate? Describe how the existing offer will be integrated in the project.**
